1st COUNT

STATEMENT OF OFFENCE

UNLAWFUL ENTERING INTO A NATIONAL PARK c/s 21(1)(a) and (2) and 29(1) of the National Park Act, Cap. 282 vol. vii of the Laws as amended by the Written Laws (Miscellaneous Amendments) Act No 11/2003.

PARTICULARS OF OFFENCE:

DANIEL S/O MIKAELI @ MTATIRO, SAMSON S/O MSOBA @ CHACHA and CHACHA S/O MKURU @ CHACHA are jointly and together charged on the 02nd day of December, 2012 at Meza area in Serengeti National Park within Serengeti District in Mara Region, were found to have entered therein without permission of the Director thereof previously sought and obtained.

2nd COUNT

STATEMENT OF OFFENCE:

UNLAWFUL POSSESSION OF WEAPONS IN THE NATIONAL PARK c/s 24(1) (b) and (2) of the National Park Act, Cap. 282 vol. vii of the laws (R.E. 2002).

PARTICULARS OF OFFENCE:

DANIEL S/O MIKAELI @ MTATIRO, SAMSON S/O MSOBA @ CHACHA and CHACHA S/O MKURU @ CHACHA are jointly and together charged on the same date and place, were found in unlawfully possession of weapons to wit: one knife two pangas and five animal trapping wires without permit and failed to satisfy an authorized officer that the same were intended to be used for the purpose other than hunting, killing, wounding or capturing of an animal.

3rd COUNT:

STATEMENT OF OFFENCE:

UNLAWFUL POSSESSION OF GOVERNMENT TROPHY c/s 86(1) and (2) of the wildlife Conservation Act, 5/2009 read together with paragraph 14 (d) of the first schedule to and section 57(1) and section 60(2) of the Economic and Organized Crime Control Act, cap. 200 of the laws (R.E. 2002).
