STATEMENT OF OFFENCE: Entering into a Game reserve c/s 15 (1) and (2) of wildlife conservation Act no 5 2009

PARTICULARS OF OFFENCE: That the accused persons are jointly charged on 28 day of September, 2012 at Rwamchanga river area, into Ikorongo game reserve within Bunda District in mara Region, were found entered into the said area without having any written permit from the Director of Wildlife.

2nd COUNT:

STATEMENT OF OFFENCE: Unlawful Possession of Weapons in a Game Reserve c/s 17 (1) and (2) of wildlife conservation Act no 5 of 2009 read together with paragraph 14(c) of the first schedule to the Economic and Organized Crime Control Act Cap. 200 (R.E 2002)

PARTICULARS OF OFFENCE: That the accused persons are jointly charged on 28 day of September, 2012 at Rwamchanga River area, into Ikorongo Game Reserve within Bunda District in Mara Region, were found in possession of weapons to wit: one knife, One bush knife, four arrows, one bow and into the said game reserve without permit and failed to satisfy to the authorized Officers that the said weapons were intended to be used for the purpose other than hunting, killing, wounding or capturing of Animals.

3rd COUNT:

STATEMENT OF THE OFFENCE: Unlawful hunting in a Game Reserve c/s 19(1) and 2(a) of the wildlife conservation Act, no 5 of 2009 read together with Paragraph 14(a) of the first schedule to the Economic and Organized Crime Control Act Cap. 200 (R.E 2002)

PARTICULARS OF OFFENCE: That the accused persons are jointly charged on 28 day of September, 2012 at Rwamchanga River Area within Ikorongo game Reserve, Bunda District in Mara Region, was found in possession of Government Trophy to wit: full carcass of zebra valued Tanzania Shillings 1920000/= the property of Tanzania Government without any permit from the Director of Wildlife.
