## **FACTS OF THE OFFENCE**

- (1) The personal particulars of accused person is as per the charge sheet.
- (2) On 4/3/2010 guards with Ant Poaching Unit who are stationed at Arusha were informed that at accused's residence situated at Baraa in Arumeru District there were trophies which were unlawfully kept there. The guards went to search accused's residence and recovered 4 live crowned cranes, 6 African Crown Eagles, 2 live marchal eagles, 3 live bine Monkeys, 8 live green pigeon, 4 live olive pigeon, 18 live green turaco and 105 live finches and 30 live yellow fronted canaries all valued Tshs. 5.089.350/= property of Tanzania Government
- (3) Accused was arrested and later arraigned before this court.

**Accused:** The facts are true and correct.

**Court:** Accused's plea of guilty is unequivocal, I hereby convict accused in the charge he is charged on his own plea of guilty.
