JUDGEMENT

The accused person one **ANTHONY S/O CHILANGAZI KASUGA** is charged with the unlawful possession of Government trophies contrary to section 86(1)(2)(c)(ii) 3(b) of the Wildlife Conservation Act .5 of 2009 read together with paragraph 14(d)of the first schedule and sections 57(1) and 60(2) of the Economic and Organized Crime Control Act [Cap 200 R:E 2002], The incident is allege to have taken place on 10th day of March at Chanumba Village within Chamwino District in Dodoma Region.

It was alleged by the prosecution side around 16:00hrs A/INSP.MATEJA FANUEL while at police station at mvumi got orders from OCD stationed at Chamwino District to do an operation of arresting the witchdoctors who do not have licenses to operate and those who have in their possession Governments Trophies, therefore managed to find in accused house, 1 honey burger skin valued at Tsh 549,600, one pangolin skin valued at Tsh 1,758,720 2 Cobra's skin valued at Tsh 311,440, one Python's skin valued at Tsh 659,520, one Hyena's tail valued at 1,007,600, one Mangore skin valued at Tsh 109,920 making the grand total of all trophies to be total Tsh 4,396,800 being the properties of The United Republic Of Tanzania.

During the trial hearing, the charge was read and explained to all accused person, hence all pleaded guilty and admitted all the facts of the case and he is convicted as he was charged forthwith.

Previous Criminal Records

S/A: Your honor, we have no previous records of the accused person but we pray that the accused be punished accordingly

MITIGATION

I pray for leniency punishment because am a very old man. I have told this court there I found no need to waste the previous time of this court and these things I inherited from my grandmother

and I kept the said property at home. Apart from that I have so many dependants at home and other children are going to school and they depend on me

SENTENCE

The accused mitigation has taken into consideration he is hereby sentenced to pay fine of Tsh 50,000 or to serve three (3) jail in default of fine.
