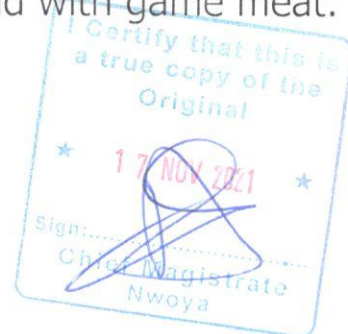

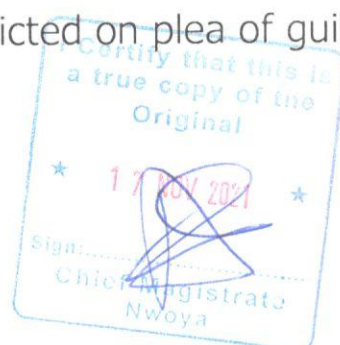

Pros:

In count one, under S.70 of the act, the maximum is 10 years' imprisonment or a fine 7 million maximum. We have no record of conviction.

I pray for seven years because the accused never wasted time in the event of fine, I pray for five million.

In count two, the maximum is life imprisonment or a fine of not exceeding 20 million. I pray for 10 years imprisonment.

Count one:

In the event of a fine, I pray for 10 million each. I pray that the sentences be served concurrently. A12 is a juvenile.

Counsel the convicts are first time offenders.

A15: I pray for five months imprisonment, I am an orphan.

Counsel Odyek: These are five time offenders, they are remorseful and have not wasted time. In the act the first option is compensation. It is my prayer that they each pay 5 million or four years.

Reasons: These offences are so rampant calling for deterrence. The personalities were enhanced to serve as a deterrence.

Sentence: In count one, the convicts are sentenced to one year imprisonment.

In count two, the convicts are sentenced to three years



imprisonment. The sentences run concurrently. A12 remanded.

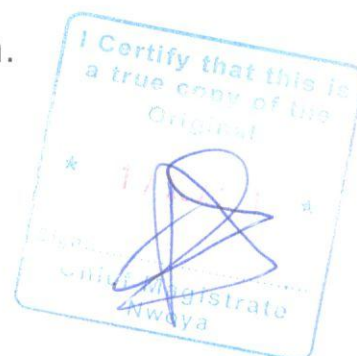
Juvenile in court.
