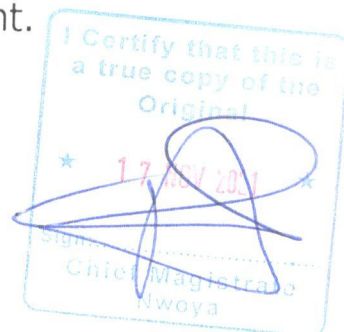
A1 in Mitigation: I have children and wife whom I take care, I pray for leniency.
