Pros: The accused persons pleaded guilty and this



matter is coming up for brief facts.

***Pros brief facts:***

The two accused persons before court and others still at large on the 19/2/2018 about 10:30 am when the accused persons were arrested when they entered into wildlife protected area and they were also found in possession of devices capable of killing and injuring wildlife protected species, they had two pangas.

A 1: The facts are true as stated by prosecution.

wildlife species, I pray for a custodial sentence to send a strong message to would be offenders.

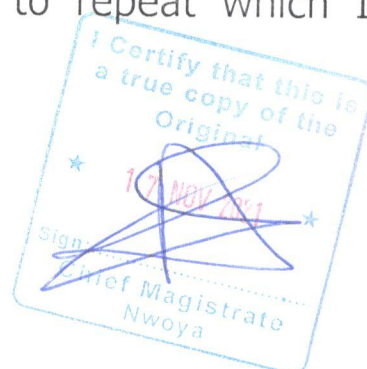
***Convicts in mitigation:***

A 1: I am a soul breadwinner for my old mother and my siblings, I pray to court to be lenient and give me community service.

A 2 mitigation: This is my first time to come to court and I am very sorry for the acts I have done, I pray to court to forgive me and be lenient.

***Court sentence:***

The two convicts are first offenders with no known criminal record, they both pleaded guilty to the charges thus saving court time and resources. A 1 told court he is a sole bread winner for his mother and siblings and asked court to be lenient to him. A2 also told court it was his first time to commit such offence, he asked court to forgive him and promised not to repeat which I have



taken into due consideration. I have also taken in to account the two months both convicts spent on remand however the offence relating to wildlife are becoming rampant and also a threat to wildlife species thus calls for tough measures to be put in place thus the convicts are hereby sentenced to:-

1. On count one to one-year imprisonment each and on the 2<sup>nd</sup> count both convicts are sentenced to one-year imprisonment, the imprisonment sentence to run concurrently. Right of appeal explained.
