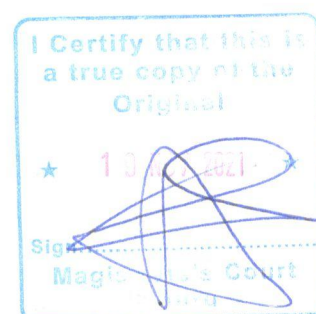

A2: I had dislocation on my shoulder. I have knee problems with 17 Children.

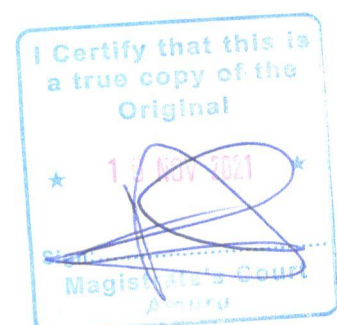
A3: I have 28 children

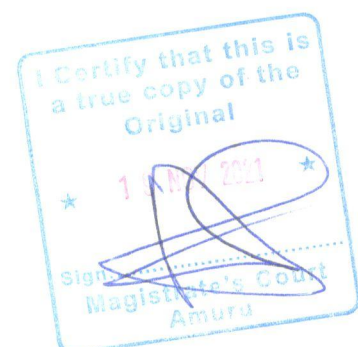
