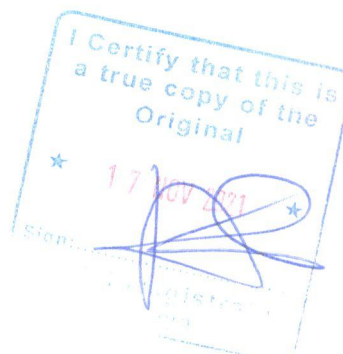

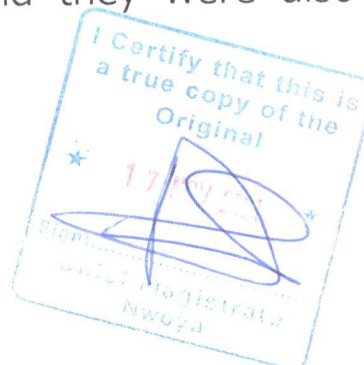
Court:

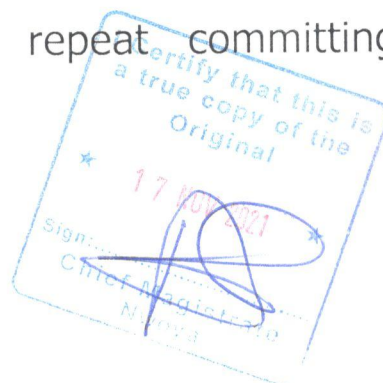
AIV: The facts are true.

The juvenile are first time offenders with no past criminal record, they both pleaded guilty to the charge thus saving court's time and resources they both asked court for forgiveness and told court they will never commit and offence thus in consideration as the above, AIII & AIV are hereby sentenced to a caution and AI & AII are remanded for sentence to 28/6/18.
