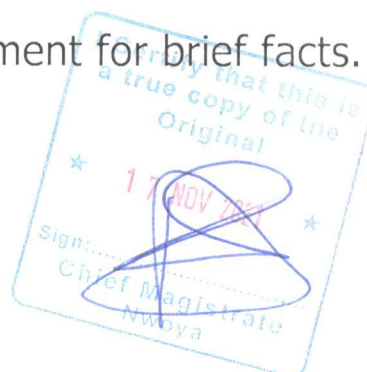

A 2: No objection and the facts are true.

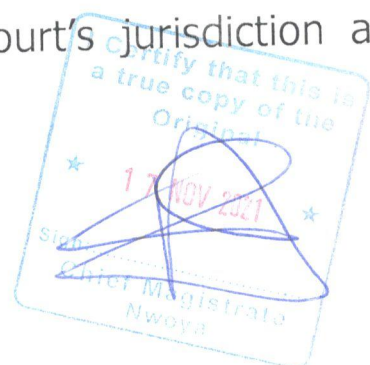
Court: Both accused persons are hereby convicted of all the three counts on their own plea of guilty.
